



The Palestinian Affairs Unit in Jerusalem Announces The 2022 TechWomen Program

The Palestinian Affairs Unit in Jerusalem and the U.S. Department of State's Bureau of Educational and Cultural Affairs (ECA) are pleased to announce the TechWomen 2022 program. TechWomen is a professional exchange that directly supports the U.S. foreign policy goal of advancing the status of women and girls around the world and promotes development in the fields of Science, Technology, Engineering, and Math (STEM) to enable women to reach their full potential. Approximately 113 professional women working in STEM fields from 21 countries in North Africa and the Middle East, Sub-Saharan Africa, and South and Central Asia will travel to the United States in February 2022 for an intensive exchange focused on promoting collaboration in science and technology. Women will select one of six tracks: information technology, green technology, science, internet, biotechnology, or telecommunications when applying. Applicants must have strong English skills as the program is conducted entirely in English.

The U.S.-based exchange for TechWomen participants will take place over a five-week period in February and March 2022. The program will begin in California in Silicon Valley with a Tech Bootcamp Week, followed by individual 15-day fellowships at leading innovation companies and organizations in Silicon Valley and the San Francisco Bay area. TechWomen 2022 will conclude with a three-day program in Washington, D.C. Each participant will complete a mentorship program and each participating country will work as a team with impact coaches to formulate an action plan to address a socioeconomic challenge in their home communities. The teams will pitch their projects in a competition, with the winners receiving seed funding. Participants will also engage in community service projects in California and participate in cultural and recreational activities. TechWomen 2022 will conclude with a three-day program in Washington, D.C., including a visit to the State Department to allow participants to brief State representatives on their exchange experiences and team projects.

The TechWomen program takes the health and safety of our 2022 Emerging Leaders, mentors, and host company partners seriously, and is taking all necessary steps to ensure we can deliver a safe and successful program. While we are planning for an in-person program for TechWomen 2022, program details are subject to change based on the latest health regulations, guidelines and best practices.

Participant Qualifications:

- Palestinian residents of Jerusalem, the West Bank, or Gaza.
- Women with a minimum of two years full-time professional experience in the Science, Technology, Engineering and Math (STEM) fields and/or a career requiring significant expertise/knowledge/application of technology;
- Bachelor's degree/four-year university degree or equivalent;
- Proficient in written and spoken English;
- Demonstrate a willingness to participate in exchange programs, welcome opportunities for mentoring and new partnership development, and exhibit confidence and maturity;

- Not have applied for an immigrant visa to the United States, or participated in a visa lottery in the past five years;
- Proven record of voluntary or public service in their communities;
- Demonstrated track record of entrepreneurialism and commitment to innovation;
- Demonstrate themselves as emerging leaders in their chosen professional track through their work experience, volunteer experience, community activities and education.

Important Note:

- Participation in the program is contingent upon the applicant qualifying for a J-1 visa to the United States.
- Holders of American passports or green cards are **not eligible to participate** in this program.
